- Convenience with 20 distribution outlets nationwide.

How It Works:

1. Nominate the maximum number of cylinders you need.
2. Return empty cylinders and exchange for full cylinders of any size (small, medium, large) – you pay only for the refrigerant for up to 90 days.
3. Return part-filled cylinders to receive a Gas Top-Up Credit², subject to weight limits.

Gas Top-Up Credit Service.

No Gas Credit Service fee on Top-Up cylinders for Gas2Go Club members.

Cylinder Size	Capacity	Minimum kg processed	Maximum kg processed
Small	9–12kg	3kg	7kg
Medium	18–22kg	5kg	12kg
Large	50–65kg	15kg	30kg

Gas credits are calculated on net gas weight, rounded down to the nearest 0.5kg, up to the maximum limit.

Example 1: Small 10kg cylinder with 8kg refrigerant → Max processed: 7kg → Credit based on 7kg.

Example 2: Medium 22kg cylinder with 11.4kg refrigerant → Rounded down to 11kg → Credit based on 11kg.

**Minimum and maximum kg limits apply.*

**Credits do not apply to Tiny cylinders.*

**Gas credits will not be paid if the RPD has been damaged or removed.*



Gas Top-Up Credit Service.

Cylinder Service Rate (Gas2Go Club)

Refrigerant cylinders incur a daily rental charge after the 90-day free rent period.

Example 1: Returned within 90 days → \$0 charge.

Example 2: 98 days held → $\$0.30 \times 8 \text{ days} = \$2.40 + \text{GST}$.

Lost or Damaged Cylinder Charges

Cylinders not returned within 12 months are deemed lost.

Replacement value varies with market rates. After 12 months you will automatically be invoiced for the replacement cost.

Service Rate for Refill Protection Device (RPD) Charge

Refrigerant cylinders returned with the RPD damaged or removed incur a cylinder cleaning and replacement charge identified as: "RPDCHARGE" of \$155.00 + GST.

Service Rate for Cylinder Valve Cap Replacement

Refrigerant cylinders that are returned without the cap incur a charge "CAPCHARGE" of \$15.00 + GST.



Special Programs.

Ready2Pumpdown – Clean cylinders for temporary refrigerant storage during maintenance.

- Free rent for 30 days, then a daily service fee applies at \$0.30/day rental.
- Sizes: Medium (22L), Large (65L), Half Tonne – Price on application.

Ready2Reclaim – Cylinders for reclaiming refrigerant for destruction or recycling.

- Free rent for 30 days, then \$0.30/day rental.
- Sizes: Small, Medium, Large (Tiny cylinders are excluded).

Return your Ready2Reclaim cylinders and receive credits back to your account.

To comply with best practice standards, your returned refrigerant will be tested through our laboratory and determined to be either a Level 1 or Level 2 grade product.

- › **Level 1** Grade Returns are scenarios where there is only one type of refrigerant within the cylinder.
- › **Level 2** Grade Returns are scenarios where multiple refrigerants are detected as well as any other foreign substances.

Level 1 Grade Product	\$30.00 per KG
Level 2 Grade Product	\$20.00 per KG

TERMS & CONDITIONS

1. General

All memberships, sales, hires, and services provided by Gas2Go® ("Gas2Go") are subject to these Terms and Conditions ("Conditions"). No variation will be binding unless agreed in writing by Gas2Go.

2. Interpretation:

2.1. The following terms shall have the following meanings unless the context shall require otherwise: -

"Conditions" means these Gas2Go Club terms and conditions, the Gas2Go terms of sale and hire, the general warranty conditions of Gas2Go, any other any agreed written variations. If there is any conflict, then in the absence of an express written variation from Gas2Go, the warranty provided on the Gas2Go website from time to time shall apply.

"Fleet" the maximum number of cylinders as nominated by you in your Gas2Go Membership application[CB1] [KB2] and is your maximum number in its entirety across the group.

"Gas2Go Club" means a membership-based club, which entitles Gas2Go Members to participate in Gas2Go gas management system through which Gas2Go provides Goods to its members.

"Gas2Go Goods" means the goods provided to Gas2Go members.

"Gas2Go Members" means a buyer who is accepted by Gas2Go as a current member of the Gas2Go Club pursuant to Gas2Go Club Conditions.

"Gas2Go Club Membership Conditions" means the terms and conditions of membership of the Gas2Go Club.

3. Gas2Go Terms and Conditions

3.1. These conditions incorporate Gas2Go's standard Terms of Sale and Hire and to the extent of any inconsistency, these conditions will prevail.

4. Prices

4.1. Gas2Go reserves the right to vary prices to reflect changes in exchange rates, freight, taxes, price of carbon, or supplier increases between the date of order and delivery. Unless otherwise agreed, all prices are ex Gas2Go's nominated warehouse. Gas2Go will advise of any price changes prior to committing to delivery should this occur.

5. Acceptance of Orders

5.1. Quotations or offers are valid for 30 days unless withdrawn earlier. Gas2Go will use reasonable efforts to meet requested delivery dates but accepts no liability for delays outside its control.

6. Membership

6.1. Membership is subject to acceptance by Gas2Go.

6.2. Gas2Go reserves the right to reject or cancel your Membership at any time.

6.3. If you do not renew your Membership, outstanding cylinders in your possession will be charged daily rental from the expiry date of Membership, and cylinder rental conditions will apply

7. Payment Terms

7.1. Invoices will be applied to your existing trade accounts with the distribution channel following supply.

7.2. Unless otherwise explicitly agreed, all invoices are payable in accordance with your existing trade accounts with the distribution channel. Gas2Go may charge interest on overdue balances at its current overdraft rate, plus debt collection or legal recovery costs.

8. Cylinders

8.1. The maximum number of cylinders that you have nominated is your Fleet and can be a combination of Gas2Go cylinders in sizes of tiny (3-5kg), small (9-12kg), medium (18-22kg), and large (50-65kg) refrigerant (Freon) cylinders. The Fleet size is the maximum number of cylinders you can have in your possession at any one time without incurring rental. A full list of Gas2Go cylinders is available in the Service Rate Charge Schedule.

8.2. The customer must declare any lost cylinders, or else they will still be considered as part of the customer's nominated

8.3. maximum which would limit the number of cylinder exchanges available to the customer. Lost cylinders are subject to the standard Gas2Go lost cylinder charge:

a) does not include Pump-down & Reclaim Cylinders.

8.4. Cylinders will be deemed lost, and customers will be charged a 'lost' cylinder fee for cylinders outstanding for more than 12 months as outlined in the Gas2Go standard terms and conditions of sale.

9. Risk and Insurance

9.1. Risk in cylinders and goods pass to you upon delivery or collection. Insurance will not be arranged by Gas2Go unless requested in writing. Ownership of cylinders remains with Gas2Go.

10. Storage/Non-Collection

10.1. If cylinders are not collected or delivered within 7 days of notification, Gas2Go may arrange storage at your cost, including handling and insurance charges.

11. Gas Credit, Fees and Charges

11.1. The cylinders, fittings, and caps supplied by Gas2Go to you as part of the Gas2Go Club, remain the property of Gas2Go and are to be returned to Gas2Go in the same condition as when received. Ordinary wear and tear accepted as outlined in the Gas2Go standard Terms of Sale and Hire.

11.2. Gas Top Up Credit is applicable on certain refrigerants in a cylinder under the nominated club.

a) Credit is calculated on the net gas weight rounded down

to the nearest 0.5kg. Gas Credit amount (kg) is determined using the table provided in the service charge schedule.

b) Cylinders must be serviceable and not damaged in any way and the Refill Protection Device (RPD) must be intact.

c) No credits will be provided for damaged cylinders and charges may apply for damaged cylinders.

d) The value will be based on the customer's current net price on the day of return or the original invoice price of the cylinder, whichever is the lesser amount will be applied to your account and is subject to normal trading terms. Any Gas Top-up Credits will be offset against the account balance and any rebates due are not available on superseded or discontinued products.

e) Service is subject to change to account for prevailing market conditions.

12. Delivery

12.1. Delivery dates are estimates only.

12.2. Gas2Go may deliver in instalments, with each instalment invoiced separately.

12.3. Delay in one instalment does not entitle cancellation of remaining deliveries.

12.4. Notwithstanding that, the title of the goods may not have passed, the risk in the goods shall pass to you, the customer upon delivery.

13. Transit Risk

13.1. All deliveries are at your risk once dispatched. Claims for loss or damage must be notified in writing within 7 days of delivery, and claims for non-delivery within 14 days of dispatch.

14. Warranty

14.1. Gas2Go's liability is limited to repair or replacement of defective goods within 12 months of invoice.

14.2. Warranty does not cover misuse, improper installation, unauthorised repair, consumables, Acts of God.

15. Force Majeure

15.1. Gas2Go will not be liable for delay or failure to perform due to causes beyond its reasonable control, including but not limited to strikes, natural disasters, or supply chain disruption.

16. Ownership and PPSA

16.1. Cylinders and goods supplied remain the property of Gas2Go until full payment is received.

16.2. You grant Gas2Go security interest under the Personal Property Securities Act 1999 (PPSA) in all present and afteracquired goods supplied, as security for payment and performance of obligations.

16.3. You waive your right to receive verification statements under the PPSA.

17. Intellectual Property

17.1. You indemnify Gas2Go against any claims for intellectual property infringement arising from Gas2Go

acting on your instructions or specifications.

18. Technical Information

18.1. Any technical or application information provided by Gas2Go is for guidance only and does not create liability. You remain responsible for determining the suitability of goods for your intended use.

19. Consumer Guarantees Act 1993

19.1. Where goods or services are acquired for business purposes, the provisions of the Consumer Guarantees Act 1993 do not apply.

20. Governing Law

20.1. These Conditions are governed by the laws of New Zealand, and both parties submit to the nonexclusive jurisdiction of the New Zealand courts.

21. Assignment

21.1. You may not transfer your rights or obligations under these Conditions without Gas2Go's prior written consent.
